# New Commander for American Legion in Corn

On May 21st, at the American Legion Oklahoma District 7 meeting, Scott Taylor was sworn in as Commander of the American Legion post 300 Corn, Oklahoma. He takes over for previous

After graduating from Clinton High School, Taylor served in the Army from 1989 to 1997. He was stationed at Kirchgoens, Germany, aka "The Rock," the same place that Elvis Presley served. Taylor deployed to Iraq in 1990-1991 with the 3rd Armored Division 3/5 Calvary Unit as a Calvary Scout and fought during the Desert Storm and Desert Shield campaigns.

Upon coming home from duty Taylor went on to earn dual degrees from Southwestern Oklahoma State University, a B.S. in both Engineering, Physics, and Finance. Taylor and his wife Michelle along with their children moved to Corn a year ago and have fallen in



# Jech Comments on Passage of Vehicle Sales Tax Exemption

A bill that would remove the 1.25% sales tax on motor vehicles and tractor trailers was approved by the Senate. A measure Sen. Darcy Jech said would provide immediate tax relief for Oklahomans needing to make vehicle purchases.

Senate Bill 1075 restores the tax exemption on motor vehicle and tractor trailer purchases that was removed in 2017 when the state was in a budget crisis and revenue was needed. Now that the economy is strong, Jech said it's the right time to remove the tax.

"I've been an advocate for removing this tax as soon as possible, even filing my own legislation to modify the tax on vehicle purchases," said Jech, R-Kingfisher. "I'm thrilled this tax relief was included in the Fiscal Year 2023 budget, which will provide immediate inflation relief for Oklahomans that need real solutions to the rising cost of goods."

SB 1075 must now be approved by the House before heading to the governor's desk for his signature. If signed into law, the tax would be removed July 1.

# Lankford, Lee Question World Health Organization Abortion Guidelines

Senators James Lankford and Mike Lee (R-UT) and Representative Doug Lamborn (R-CO) led 52 other House and Senate colleagues in sending a letter to Dr. Tedros Adhanom Ghebreyesus, the Director-General of the World Health Organization (WHO), urging a reversal on the Organization's recent guidelines on abortion. These guidelines advocate for abortion on demand and critique conscious objections of healthcare providers. The updated guidelines follow years of controversy regarding the role, allegiance, and effectiveness of the WHO.

The letter reads in part, "We, members of the US Congress, write to you today with concerns about the World Health Organization's (WHO) dangerous new abortion guidelines. These extreme new guidelines aim to remove all legal and policy safeguards on abortion, impose restrictions on the conscience rights of health workers, and ignore the right to life and the safety of the mother and child.

"Moreover, we are astonished that the WHO is attempting to de-humanize preborn children and assert that the rights of the preborn do not exist by categorizing self-induced—and, in some cases, illegal—abortions as 'self-care' and demanding 'the full decimalization of abortion' without any gestational age limits. To categorize abortions as 'self-care' not only strips away the humanity and dignity of a preborn child but also contradicts

international standards recognizing the preborn child as a rights-holding person," the Members continued. You can find the full text of the letter below:

Dear Dr. Tedros,

We, members of the United States Congress, write to you today with concerns about the World Health Organization's (WHO) dangerous new abortion guidelines. These extreme new guidelines aim to remove all legal and policy safeguards on abortion, impose restrictions on the conscience rights of health workers, and ignore the right to life and the safety of the mother and child.

While the WHO guidelines are not legally binding on any country, we are concerned that the organization is attempting to delegitimize the will of all sovereign nations by falsely asserting that abortion is a human right. This is far from an isolated instance of United Nations affiliates attempting to encroach on matters far out of their jurisdiction. Last November, for example, a United Nations special rapporteur attempted to interfere with domestic United States judicial proceedings by calling on our Supreme Court to adopt a specified outcome in the ongoing Dobbs v. Jackson's Women's Health Organization



Excise board chairman Harold Gleason said the county is in good financial shape. Discussion was held over the sheriff's budget for the next fiscal year and will wait on updated numbers in a few areas. The boards are scheduled to meet again next month to solidify the next spending plan for the county.

**CLINTON CC/EVENT APPLICATION-** Clinton City Council, acting as the industrial authority, approved an event grant application for Clinton Baseball, Inc. Billy Goodwin said the organization is bidbring at least 2000 people to Clinton.

WEATHERFORD SCHOOLS/GROWTH- As the population of Weatherford showed an increase in the last census so has student growth for Weatherford Public Schools. District Superintendent Jill Henderson said the district will need to review its needs at the higher grade levels in the coming years as enrollment projections show an expected increase in the future.

CUSTER COUNTY COMMISSIONERS/BATH-**ROOMS-** Custer County commissioners approved contracts with AIP and Rick Scott construction over possible upgrades to courthouse bathrooms. Brandon Box with Rick Scott Construction said the work will be done in phases to minimize any disruptions during business hours. The proposal is to upgrade a total of six bathrooms and add a 7th. Rick Scott construction will serve as the construction manager for the project and AIP will serve in the design phase.

**CUSTER COUNTY COMMISSIONERS/SET-TLEMENT-** Custer County commissioners approved a settlement on a road use agreement with Invenergy. County Commission chairman Bruce Walker said the settlement is for \$4.4 million. \$3.3 million will go to District 2 and \$1.1 million to District 1 for road damage by Invenergy during its windfarm project.

DEWEY CO DIST COURT/SECHRIST- The prosecution has filed a bill of particulars in Dewey County District Court, seeking the death penalty for an Apache man charged with two counts of first degree murder. Thirty-four-year-old Tye Sechrist is charged in connection with the shooting deaths of a ding to host a state tournament that is projected to Leedey EMT and her sister-in-law. A two week jury trial is set to begin October 11th for Sechrist who is accused of the 2021 shooting and killing of 44-year old Angel Boyd and 31-year old Stacy Boyd.

> WATER STUDY- Clinton Mayor David Berrong said a study to determine if it's feasible for a water pipeline to be built between Weatherford and Clinton that would make it possible to share water throughout Custer County remains on-going. The projected amount of pipeline would be about 14 miles.

> CLINTON/EXPLOSION UPDATE-As the investigation continues into a house explosion near Clinton, Custer County Sheriff's officials have released the names of those who died as a result of the incident. The victims are identified as 55-year-old Glen Penner and 66-year old Shirley Penner. The explosion occurred about 5 miles west of Clinton. The cause of the explosion remains under investigation.



She is the third SWOSU Women's Golfer to earn a spot on the WGCA All-Region team in multiple seasons, joining Elin Wahlin (2017, 2018) and Gloria Choi (2017, 2018, 2019). Five total Lady Bulldogs have earned All-Region nods, including Ashlyn Hall in 2013 and Ana Gomez in 2014.





### **Despise not Small Things**



Although I cannot find it I seem to find that statement in Scripture I'm sure I heard it somewhere. But my point is that often there are small efforts of kindness, though unnoticed

Most of you know the story of Lee Strobel and his investigation into the reality of the Christian faith from

at the time, result in major changes.

Let me explain with two illustrations:

his atheist mindset. He and his wife had moved to a new condominium. I kindly lady in a downstairs apartment brought a plate of cookies to welcome them to their new home. The lady became good friends with Lee's wife, Leslie, later inviting her to a Bible study. Over a period of time, Leslie became a believer. Seeing her change in character and manner, Lee spent two years seeking out the truth from scholars. Finally, he admitted the evidence for the reality of Christ was so strong that he surrendered his life to Christ. Since then he has written numerous books and is a popular speaker sharing the strong evidence for the resurrection of Jesus and the validity of scripture. No one really thinks about the real hero of the story. The lady that brought the plate of cookies could have ignored those neighbors upstairs. She could have been too busy or occupied with her own problems to care. Her small gesture turned two lives around and has resulted in many coming to Christ through ministry of Lee Strobel. His two children are also faithfully involved in ministry; his daughter a writer of children's Christian books and his son a Seminary professor—all because of a kind neighbor and a plate of cookies.

Recently I have been showing the video about Louis Zamperini, in the county jail. During World War 2, his plane crashed into the ocean. He and two survivors spend 47 days floating on the ocean before being rescued by the Japanese. He experienced horrible torture for two years before the camp was liberated. After returning home he was welcomed as a hero. But he couldn't escape the horrors of the prison camp. He had nightmares every night. He found that alcohol could help him blot out the past but he was soon held captive by the drug. His marriage was falling apart, his wife had filed for divorce, and he could see no way out. About that time in 1949 Billy Graham came to Los Angeles to hold a crusade


which lasted for 8 weeks. A concerned neighbor invited his wife to attend the crusade. She agreed and that night she gave her life to Christ. She was so changed that she told Louis that we had been saved and was no longer considering divorce. This thrilled Louis. Then she insisted that he attend the crusade the next night. He agreed but stormed out of the meeting when the invitation was given.

His wife persuaded him to attend the second night over his resistance. This time when the invitation was given he started to walk out again but something held him back and he found himself going forward, surrendering his life to Christ. He lost all desire for alcohol and soon began sharing his new faith across the country, even going back to Japan, speaking to his former guards, now prisoners themselves, of how God had forgiven him and he now forgave them for the harsh treatment he had endured. Many of them came to Christ.

As I showed that story on DVD, several inmates gave their life to Christ. Not many people think of that CONCERNED NEIGHBOR who invited Louis' wife to the crusade. But without that invitation, perhaps the world have never known his story and the many lives that have changed would still be lost. Be alert to small opportunities to show concern and kindness. God can use our small efforts to do great things.









case. In addition Continued from Page 3 to blatantly ignoring the life of the preborn, such statements undermine the increasingly fragile trust globally in the concept of internationally recognized human rights while discrediting the United Nations' legitimacy as a whole.

Moreover, we are astonished that the WHO is attempting to de-humanize preborn children and assert that the rights of the preborn do not exist by categorizing self-induced—and, in some cases, illegal—abortions as "self-care" and demanding "the full decriminalization of abortion" without any gestational age limits. To categorize abortions as "self-care" not only strips away the humanity and dignity of an preborn child but contradicts international standards recognizing the preborn child as a rights-holding person. Additionally, advocating for the termination of the life of a human being up to the point of birth is quite shocking and inhumane as a day, an hour, or even moments later, similar action against a child that has been born would constitute murder. Even in countries where early abortion is freely available, there are laws in place restricting abortions based on the preborn child's gestational age.

Furthermore, this guidance not only threatens the conscience rights of health care providers at all levels but treats individuals and institutions that object to abortion as obstacles. The WHO's guidance states that

"access to and continuity of comprehensive abortion care be protected against barriers created by conscientious objection" It continues further, stating "[i]f it proves impossible to regulate conscientious objection in a way that respects, protects and fulfils abortion seekers' rights, conscientious objection in abortion provision may become indefensible." Conscience protections are critical to prevent health care providers from being forced to take part in ending an innocent human life, thereby violating their ethical, moral, personal, or religious convictions. This radical stance reveals the WHO would rather cave to pressure from the abortion industry and force health care providers to choose between committing violence against an innocent baby and her mother, or be unemployed. This stance inevitably also threatens patient access to health care in geographic areas that are primarily served by faith-based health care providers as those who hold conscience objections would be deemed unfit for service.

We are also alarmed by the WHO's recommendation that women and girls seeking abortion should be allowed to take abortion-inducing drugs without medical supervision. This policy is reckless and harmful to the well-being of women and girls, especially to those living in rural areas. While abortion activists incorrectly assert abortion drugs are safe, evidence-based data signals otherwise. Large-scale, peer-reviewed studies have shown women who take chemical abortion pills are significantly more at risk of serious complications and more likely to require a visit to the emergency room, while some women even die. According to the United States Food and Drug Administration, abortion drugs have been linked to at least 24 maternal deaths, 1,045 hospitalizations, and over 4,200 serious complications between 2000 and 2021 in the United States. Encouraging the removal of medical oversight from abortion will not save lives but instead put more women and girls at risk of being targeted by illegal purveyors of abortion pills or provided with abortion drugs without consent. As such, the WHO guideline turns a blind eye to the harms of the abortion pill by providing support to those that enable abortion through the trafficking of black market abortifacients.

Every instance of abortion is a tragedy. Instead of advocating for greater access to abortion, the WHO should instead seek to address the root causes that motivate women to seek illegal abortions. This means promoting human dignity and preserving human rights for everyone, including the preborn.

Given the WHO's influence, this guidance will likely cause severe, irreversible harm, not only to US citizens but to women and children worldwide. For these reasons, we ask that the World Health Organization reverse course and retract the anti-life recommendations that it has promoted through the release of its 2022 abortion care guidelines.

# **Howard Comments On Durable Power of Attorney Act**

The governor has signed Senate Bill 1596, also known as the Oklahoma Health Care Agent Act, which establishes requirements for health care power of attorney and allows Oklahomans to make advanced decisions about their care in case they are temporarily or permanently incapacitated. The measure was authored by Sen. Brent Howard, R-Altus.


"All citizens should be able to easily and freely nominate someone to act on their behalf in the unfortunate event that they are unable to make their own health care decisions," Howard said. "After updating the Durable Power of Attorney Act during the last legislative session, we've had about a sevenmonth gap with no direct authorization for health care power of attorney. This will ensure Oklahomans will always have the right to designate a family member or friend to have their best interests in mind if they are unable to do so themselves."

Howard said the new law is supported by Oklahoma's health care agencies, hospitals and other interested parties.

Rep. Preston Stinson, R-Edmond, was the House author of the measure. The bill went into effect immediately upon the governor's signature and is now law.















